

Air Monitoring

Figure 1. Air Quality Index (AQI) Summary for 2016 Year to Date



- "Moderate" Days in May:
 - Ozone: 5 (5/4, 5/5, 5/6, 5/7, and 5/13)
 - PM_{2.5}: 7 (5/10, 5/11, 5/21, 5/24, 5/25, 5/26, and 5/28)
 - May Max 8-hour ozone (O_3) concentration: 65 ppb (93% of NAAQS)
- May Max 24-hour fine particulate matter ($PM_{2.5}$) concentration: 24.7 μ g/m³ (71% of NAAQS)
- May Max 1-hour nitrogen dioxide (NO₂) concentration: 46.9 ppb (47% of 1-hr NAAQS)
- May Max 1-hour sulfur dioxide (SO₂) concentration: 1.2 ppb (1.6% of NAAQS)

State & Federal Updates

- <u>PM National Ambient Air Quality Standard (NAAQS) Periodic Review</u>:

- Plan calls for new standard to be finalized in 2021;
- May 23, 2016: EPA Clean Air Scientific Advisory Committee meeting on Draft Integrated Review Plan (IRP) for the next review of the PM NAAQS;
- TCEQ, Gradient, and American Lung Association submitted public comments for the meeting;

- Comment period on the IRP ends on June 23, 2016;

Ozone NAAQS – Houston & Dallas Updates

- May 25, 2016: EPA published a proposed rule to approve Houston area redesignation substitute for 1997 8-hour Ozone NAAQS. Comment period closes June 24, 2016;
- 2013-2015 data shows that Houston will not attain 2008 Ozone NAAQS by July 20, 2016, and will therefore not qualify for another 1-year deadline extension. EPA expects to reclassify to Moderate with a July 20, 2018, deadline, and require a new attainment demonstration;
- May 25, 2016: EPA published a proposed rule to approve Dallas-Fort Worth area redesignation substitute for 1979 1-hour Ozone NAAQS.

Oil and Gas Rules

 In May, EPA finalized new rules for oil and gas sector, including new source performance standards to control methane and VOC and clarifications/updates to oil and gas permitting requirements;

- <u>TERP updates</u>
 - Emission Reduction Incentive Grant (ERIG) awards were announced in May;
 - \$51.9 million awarded for 559 projects;
 - 76 projects primarily in the Austin area were awarded a total of \$7.8 million (16% of total), and are projected to reduce 845 tons of NO_x over the next 7 years;

- Included two awards to CapMetro for a total of \$1.6 million to replace 52 buses;
- Average cost/ton of 2016 projects: \$9,923
- Range: \$2,746/ton NO_x reduced \$15,000/ton NO_x reduced
- New Technology Implementation Grants (NTIG) program (\$3.5 million) application selections will be finalized soon);
- Natural Gas Vehicle Grant Program (\$37.8 million) applications are being accepted on first-come, first-serve basis;
