

Air Monitoring

Austin-Round Rock MSA 2014-2016 "Design Value" through July 31, 2016: 66 ppb

Figure 1. Air Quality Index (AQI) Summary for 2016 Year to Date



- "Moderate" Days in July:
 - o Ozone: 1 (7/1)
 - o PM_{2.5}: 11 (7/2, 7/3, 7/4, 7/8, 7/9, 7/10, 7/11, 7/12, 7/13, 7/15, 7/16)
- May Max 8-hour ozone (O₃) concentration July: 59 ppb (84% of NAAQS)
- May Max 24-hour fine particulate matter (PM_{2.5}) concentration July: 28.3 μg/m³ (81% of NAAQS)
- May Max 1-hour nitrogen dioxide (NO₂) concentration July: 30.2 ppb (30% of 1-hr NAAQS)
- May Max 1-hour sulfur dioxide (SO₂) concentration July: 0.9 ppb (1% of NAAQS)

TERP Grants

- Natural Gas Vehicle Grant Program:
 - Accepting applications through May 26, 2017.
 - \$37.8 million available.
- Clean School Bus:
 - Accepting applications through November 1, 2016.
 - \$5.9 million available.
- New Technology Implementation Grants:
 - Accepting applications through October 18, 2016.
 - \$3.5 million available.
- Clean Transportation Triangle & Alt. Fueling Facilities Program (alt. fuel infrastructure):
 - Next grant round opening August 2016.
 - \$5.9 million available.
- Emission Reduction Incentive Grant Program (competitive replacement/repower/retrofit/infrastructure grant):
 - Next grant round opening in September 2016.
 - \$51.7 million expected to be available.
- Rebate Grants (replacement, repower, retrofit, specified cost/ton rebate, 1st come, 1st-served):
 - Next grant round opening in February 2017.
 - \$10 million expected to be available.

• Drive a Clean Machine (DACM) Program

- Travis and Williamson Counties only.
- o Provided approximately \$170,000 in assistance March 1, 2016 May 31, 2016.
- Funding paid for 57 vehicle emissions repairs and 46 vehicle retirements/replacements.

• Volkswagen Settlement:

- EPA announced a partial settlement of the VW litigation on June 28, 2016, to address the 2.0 liter cars on the road.
- Settlement doesn't cover pending claims for civil penalties or complaints regarding 3.0 liter diesel vehicles or any potential criminal liability.
- VW will be required to remove or retrofit at least 85% of the affected vehicles and must offer every owner and lessee an option of a buyback or lease termination.

- Settlement includes a \$2.7 billion mitigation trust fund and a requirement to invest an additional \$2 billion to promote the use of zero-emission vehicles and technology.

• State Implementation Plan (SIP) Updates

- TCEQ adopted SIP revisions for the Dallas-Fort Worth 2008 O₃ Nonattainment Area at its July 6, 2016 meeting. For more information, go to: https://www.tceq.texas.gov/airquality/sip/dfw/dfw-latest-ozone.
- EPA expects to propose reclassifying the Houston nonattainment area for the 2008 O₃
 NAAQS from "Marginal" to "Moderate," which would mean that TCEQ would need to submit a new set of SIP revisions for the area, including a attainment demonstration showing that the area will attain the 2008 O₃ NAAQS by the end of the 2017 O₃ Season.

• New TCEQ Photochemical Modeling Data

- TCEQ has posted new photochemical modeling data for a May September 2012 that will be used as the basis for future photochemical modeling efforts for the state.
